BE IT RESOLVED, that this Board determines and declares its intent to establish a Purchase of STRS service credit, in accordance with O.R.C. 3307.54, with the following terms and conditions:

- 1) The plan will be in effect during the period of July 1, 2011 through June 30, 2012.
- 2) The plan is open to any employee (including Administrators and exempt employees along with teachers) who is a member of STRS, provided the employee has attained the age of fifty (50) and the employee agrees to retire, and actually retires within ninety (90) days after receiving notice from STRS that service credit has been purchased for the member.
- 3) The number of years of service credit to be purchased for eligible employees is one (1) year.
- 4) The Board will purchase the entire cost of the service credit.
- 5) This Board does not intend to limit the number of persons for whom it purchases credit in accordance with this plan.

BE IT FURTHER RESOLVED, that the Board's Treasurer is authorized and directed to initiate all further acts, documents, timeframes, and procedures necessary to implement this plan.
