On July 1, 2003, Madison-Plains Local Schools issued \$319,550 in energy conservation bonds. The purpose of the bonds was to reduce energy consumption in district buildings. The bonds were scheduled to be paid over a 14 year period at an annual average interest rate of 3.66%. The principal balance to be paid as of 1/1/2012 is \$140,000.00. By paying this debt off, the district will save \$19,602.50 and will become debt free.
