- M2. Upon recommendation of the superintendent, the board retroactively affirm Rebecca Hufford-Shuler to work in art classes in grades 7-12 during the 2nd-semester for the 2023 -- 2024 school year and to be compensated in accordance with the Board action taken at its public meeting on August 15, 2023.
- M3. Upon recommendation of the superintendent, the Board accept, with regret, the resignation of Skylar Stewart, effective at the end of the current contract year.
- M4. Upon recommendation of the superintendent, the Board accept, with regret, the resignation of Rebecca Hufford-Shuler, effective at the end of the current contract year.
- M5. Upon recommendation of the Superintendent, the Board conditionally employ Skylar Stewart on a 1 year contract for the 2024 -- 2025 school year. The conditions are if Miss Stewart has an alternative license to teach art by June 30, 2024, she will be employed as an art teacher; if she does not, she will be employed as a long-term floating substitute teacher. Salary to be paid in accordance with the board approved salary schedules, beginning with the 2024-2025 school year. Health, dental, and vision insurance shall be provided beginning on the first day of employment under either of these contracts.
- M6. Upon recommendation of the Superintendent, the Board conditionally employ Rebecca Hufford-Shuler on a 1 year contract for the 2024 -- 2025 school year. The conditions are if Mrs. Hufford-Shuler has an alternative license to teach art by June 30, 2024, she will be employed as an art teacher; if she does not, she will be employed as a long-term floating substitute teacher. Salary to be paid in accordance with the board approved salary schedules, beginning with the 2024-2025 school year. Health, dental, and vision insurance shall be provided beginning on the first day of employment under either of these contracts.
- M7. Upon recommendation of the superintendent, the board accept, with regret, the resignation of Marc Chalmers, English teacher, effective at the end of the current contract year. Mr. Chalmers has served the Madison-Plains Local School District for one year.
