Advising Acknowledgement

Each student admitted to the College Credit Plus program is required to attend the Madison Plains College Credit Plus Parent/Student meeting or meet with the high school counselor prior to enrolling in courses. During either of these meetings, each student will be provided the following information pertaining to academic resources, policies and expectations of students. Before signing this document, please attest to the following statement by placing a check in each box:

- I have been made aware of the academic impact of dropping a course after the no-fault withdraw date.
- I have been made aware of the athletic eligibility requirements.
- I have been made aware that each student cannot go over the 30 credit hours per academic year which includes summer, fall and spring (including regular high school courses scheduled in that year).
- I have been made aware of the textbook purchasing policy.
- I have been made aware of the deadlines to participate in CCP.
- I have been made aware that students are responsible for providing their own computer and internet technology if enrolling in an online course outside the Madison Plains campus.
- I have been made aware that all students are responsible for the cost of transportation and parking fees if taking courses outside the Madison Plains campus.

Financial Obligations

By registering for classes, you incur a legal obligation to reimburse Madison Plains Local Schools tuition and book fees in the event a student either withdraws from courses after the no-fault withdraw date or earn failing grades. This obligation will be cancelled only if the student officially cancels the course registration before the deadline. Refer to the applicable schedule of classes from the college you are planning to register classes through for detailed information on cancellation deadlines.

Potential Risks of Participation

There are risks involved that students should consider as they are deciding whether or not to participate. Students should talk through the pros and cons of participating with their parents or guardians and school counselor prior to registering for classes.

- Students who participate initiate a permanent academic record that will follow them to any other college or University.
- Earning poor grades could negatively impact eligibility for admission at other universities as a degree seeking student.
- Students who fail or withdraw from courses **WILL** be asked for reimbursement for the cost of tuition and books.
- Although certain courses are guaranteed to transfer to Ohio public institutions, they may not be accepted at private and out-of-state institutions.
- Financial aid eligibility as a degree seeking student is based on degree completion within a certain time period. Course credit earned through the CCP program will count in determining eligibility.
- Not all college courses will satisfy high school graduation requirements.
- Prior to enrolling in an online course, students should ensure access to appropriate computer and internet technology. Lack of access may prevent a student from completing assignments and participating in course discussion which could negatively impact the grade earned.
- If a student fails a course or withdraws after the deadline, the student is required to pay for all books for that course including tuition which is per credit hour. This could add up to a very expensive fee on you and your family. (Example: A course is 3 credit hours. College charges \$160 per credit hour, 3 X \$160 = \$480.00 + cost of books)
